## Fund Description

The **Market Vectors Brazil Small-Cap ETF** seeks to replicate as closely as possible, before fees and expenses, the price and yield performance of the **Market Vectors Brazil Small-Cap Index**. The Index is comprised of securities of small-capitalization companies that are incorporated in Brazil or that generate at least 50% of their revenues (or, in certain circumstances, have at least 50% of their assets) in Brazil.

Averages are market weighted. Price/Book Ratio is the price of a security divided by the book value per share of the security. Market Capitalization of an individual, publicly traded company is calculated by multiplying the company's stock price by the total number of its shares outstanding. 30-Day SEC Yield is a standard calculation developed by the Securities and Exchange Commission that allows for fairer comparisons among funds. It is based on the most recent 30-day period and reflects the investment income earned after deducting a fund's expenses for the period.
