Fund Description

The Market Vectors High-Yield Municipal Index ETF seeks to replicate as closely as possible, before fees and expenses, the price and yield performance of the Barclays Municipal Custom High Yield Composite Index. The index is intended to track the overall performance of the U.S. dollar denominated high yield long-term tax-exempt bond market.

After-tax returns are calculated using the historical highest individual federal marginal income tax rates and do not reflect the impact of state and local taxes. Actual after-tax returns depend on the investor's tax situation and may differ from those shown. It is based on the most recent 30-day period and reflects the investment income earned after deducting a fund's expenses for the period.
