Fund Description

The Market Vectors Intermediate Municipal Index ETF seeks to replicate as closely as possible, before fees and expenses, the price and yield performance of the Barclays AMT-Free Intermediate Continuous Municipal Index. The index is intended to track the overall performance of the U.S. dollar denominated intermediate-term tax-exempt bond market.

It is based on the most recent 30-day period and reflects the investment income earned after deducting a fund's expenses for the period.
