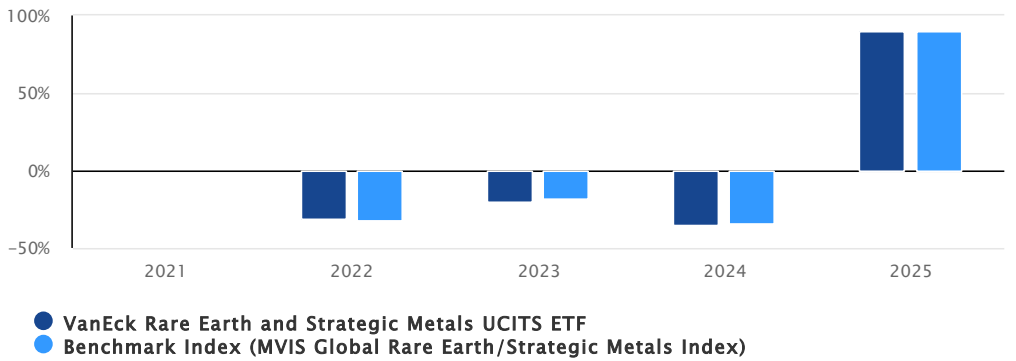
Fund Description
