## What is this Product?

<b>Type:</b>	The Product is a passively managed UCITS ETF of VanEck UCITS ETFs plc, an umbrella fund structure comprising different sub-funds. Under Irish law, VanEck UCITS ETFs plc has segregated liability between its sub-funds. VanEck UCITS ETFs plc does currently not offer an exchange of shares for shares of another sub-fund. The shares are admitted for trading on various stock exchanges and can be traded on the secondary market. The price of the shares offered on the secondary market may deviate from the net asset value of the shares.
<b>Term:</b>	No fixed term. We are entitled to terminate the management of the Product by giving at least one month notice to investors as published at least on our website.
<b>Objective:</b>	<p>The Product's investment objective is to track, before fees and expenses, the price and yield performance of the MVIS Global Junior Gold Miners Index (the "Index").</p> <p>In order to seek to achieve its investment objective, the investment policy of the Product is to invest in a portfolio of equity securities that as far as possible and practicable consists of all or substantially all of the component securities of the Index. The Index includes companies that generate at least 50% (25% of current components) of their revenues from gold mining and/or silver mining or have mining projects with the potential to generate at least 50% of their revenues from gold and/or silver when developed. Such companies may include smaller companies and foreign issuers. At each quarterly review, the Index limits the maximum weight of any single stock to 7%.</p> <p>The Product may invest up to 15% of its Net Asset Value directly in shares issued by companies listed on the Shanghai Stock Exchange or the Shenzhen Stock Exchange.
