In order to seek to achieve its investment objective, the investment policy of the Product is to invest in a portfolio of equity securities that as far as possible and practicable consists of all or substantially all of the component securities of the Index. The Index includes companies that generate at least 50% (25% of current components) of their revenues from gold mining and/or silver mining or have mining projects with the potential to generate at least 50% of their revenues from gold and/or silver when developed.
