# What is this Product?

The Product is a passively managed UCITS ETF of VanEck UCITS ETFs plc, an umbrella fund structure comprising different sub-funds. Under Type:

Irish law, VanEck UCITS ETFs plc has segregated liability between its sub-funds. VanEck UCITS ETFs plc does currently not offer an exchange of shares for shares of another sub-fund. The shares are admitted for trading on various stock exchanges and can be traded on the secondary

market. The price of the shares offered on the secondary market may deviate from the net asset value of the shares.

The Product's investment objective is to track, before fees and expenses, the price and yield performance of the Morningstar® Global Wide Moat Objective: Focus Index™ (the "Index").

> In order to seek to achieve its investment objective, the investment policy of the Product is to invest in a portfolio of equity securities that as far as possible and practicable consists of all or substantially all of the component securities of the Index. The Index is comprised of securities issued by companies globally that the Index Provider determines have an attractive fair value price ratio and sustainable competitive advantages based on a proprietary methodology that considers quantitative and qualitative factors ("wide moat companies"). At each semi-annual review, approximately half of the portfolio held will be rebalanced to equal weights and may result in purchase or disposal of certain securities. The Index will consist of a maximum of 100 equity securities.

### What happens if VanEck Asset Management B.V. is unable to pay out?
