## What is this Product?

Type: The Product is a passively managed UCITS ETF of VanEck UCITS ETFs plc, an umbrella fund structure comprising different sub-funds. Under

Irish law, VanEck UCITS ETFs plc has segregated liability between its sub-funds. VanEck UCITS ETFs plc does currently not offer an exchange of shares for shares of another sub-fund. The shares are admitted for trading on various stock exchanges and can be traded on the secondary

market. The price of the shares offered on the secondary market may deviate from the net asset value of the shares.

Term: No fixed term. We are entitled to terminate the management of the Product by giving at least one month notice to investors as published at least

on our website.

Objective: The Product's investment objective is to track, before fees and expenses, the price and yield performance of the Morningstar®US Sustainability

Moat Focus Index<sup>™</sup> (the "Index"). In order to seek to achieve its investment objective, the Manufacturer will normally use a replication strategy by investing directly in the underlying equity securities of the Index, which will be primarily listed on US stock exchanges. The Index is designed to provide exposure to at least 40 of the top equity securities in the Morningstar US Market Index (parent index) that are rated as wide moat companies and have the lowest current market price/ fair value price determined in an independent research process by the Morningstar equity research team. Companies selected into the Index are compliant with Environmental, Sustainability and Governance (ESG) criteria.

The Manufacturer has categorised the Product as meeting the provisions set out in Article 8 of Regulation (EU) 2019/2088 on sustainability related disclosures in the financial services sector ("SFDR") for products, which promote environmental and/or social characteristics and invest in companies that follow good governance practices. The Product does not have sustainable investment as its investment objective. The Index

considers ESG factors as further detailed in the Index methodology available on the Index Provider's website and in the Prospectus.

The Product may also (or alternatively) invest in financial derivative instruments (FDIs) which relate to the Index or constituents of the Index. The FDIs which the Product may use are futures, swaps, non-deliverable forwards (a forward contract that does not require settlement on maturity) (NDFs). Where it is not practical or cost efficient for the Product to fully replicate the Index, the Manufacturer may utilize an optimized sampling methodology. Furthermore, the Product may not invest less than 51% of its Net Asset Value in equity securities which constitute "equity participation" within the meaning of section 2, Article 8 of the German Investment Tax Act. # What happens if VanEck Asset Management B.V. is unable to pay out?
