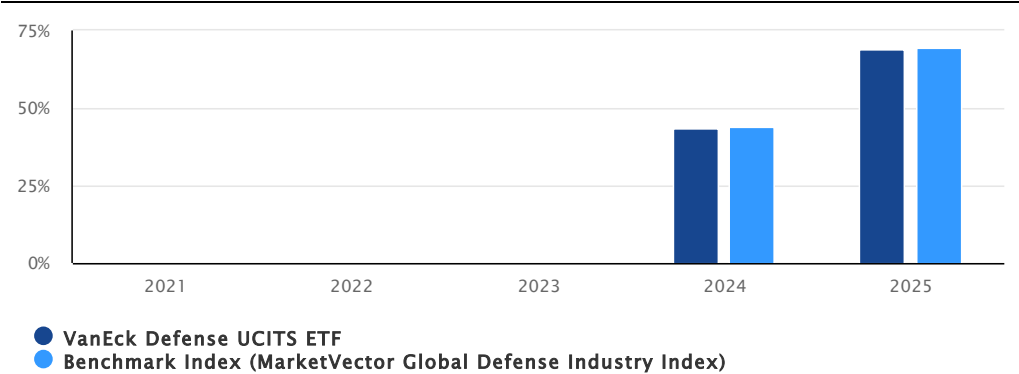
The MarketVector™ Global Defense Industry Index tracks the overall performance of companies serving national defense industries.
