

A Growing Sector Within Emerging Markets Corporate Bonds


High yield emerging markets corporate bonds make up an increasingly large portion of the overall emerging markets corporate bond market, which itself is now larger than the U.S. high yield market.

ETF Net Asset Values (NAVs) are determined at the close of each business day, and represent the dollar value of one share of the fund; it is calculated by taking the total assets of the fund, subtracting total liabilities, and dividing by the total number of shares outstanding.
