## Fund Description

The VanEck Vectors<sup>®</sup> AMT-Free Short Municipal Index ETF (SMB<sup>®</sup>) seeks to replicate as closely as possible, before fees and expenses, the price and yield performance of the Bloomberg Barclays AMT-Free Short Continuous Municipal Index (LMT1TR), which is intended to track the overall performance of the U.S. dollar denominated short-term tax-exempt bond market.

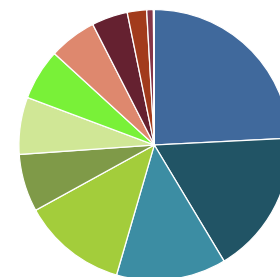
