What is this Product?

Type:	<p>The Product is a passively managed UCITS ETF of VanEck UCITS ETFs plc, an umbrella fund structure comprising different sub-funds. Under Irish law, VanEck UCITS ETFs plc has segregated liability between its sub-funds. VanEck UCITS ETFs plc does currently not offer an exchange of shares for shares of another sub-fund. The shares are admitted for trading on various stock exchanges and can be traded on the secondary market. The price of the shares offered on the secondary market may deviate from the net asset value of the shares.</p>
Term:	No fixed term. We are entitled to terminate the management of the Product by giving at least one month notice to investors as published at least on our website.
Objective:	<p>The Product's investment objective is to replicate, before fees and expenses, the price and yield performance of the S&P Global Mining Reduced Coal Index (the "Index"). In order to seek to achieve its investment objective, the policy of the Product is to invest directly in the underlying equity securities of the Index, being the stock, American depository receipts, global depository receipts, China B and China H shares issued by mining and metals companies whose predominant economic activity is the production of base metals and industrial such as iron ore. Further, the Product may hold the equity securities of companies whose predominant economic is in gold or other precious metal of mineral mining, however the Product does not hold physical gold or metal.</p> <p>Where it is not practical or cost efficient for the Product to fully replicate the Index, the Investment Manager may utilise an optimized sampling methodology.</p> <p>The Product may also or alternatively invest in financial derivative instruments which relate to the Index or constituents of the Index.</p> <p>Further, the Product may use futures, swaps (for example Index swaps and equity swaps), currency forwards and non-deliverable forwards (a forward contract that does not require settlement on maturity), American depository receipts, global depository receipts or participation notes.</p> <p>The Product may invest up to 15% of its Net Asset Value directly in shares issued by companies listed on the Shanghai Stock Exchange or the Shenzhen Stock Exchange. What are the risks and what could I get in return?



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

It shows how likely it is that the Product will lose money because of movements in the markets or because we are not able to pay you. We have classified this Product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high. Furthermore, poor market conditions will likely impact the capacity of Manufacturer to pay you. **Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. What happens if VanEck Asset Management B.V. is unable to pay out?
