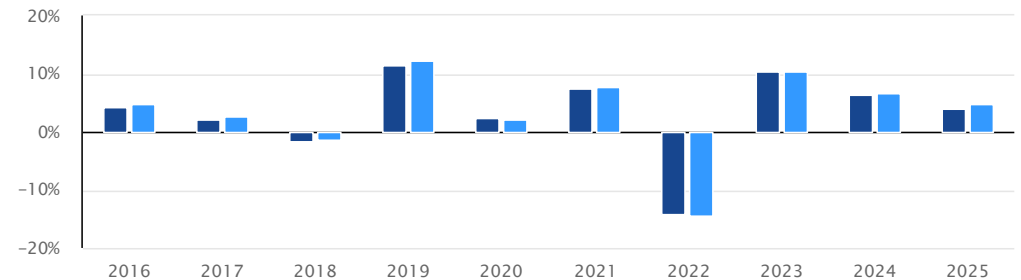
Fund Description
