What is this Product?

| Type: | The Product is a passively managed UCITS ETF of VanEck UCITS ETFs plc, an umbrella fund structure comprising different sub-funds. Under Irish law, VanEck UCITS ETFs plc has segregated liability between its sub-funds. VanEck UCITS ETFs plc does currently not offer an exchange of shares for shares of another sub-fund. The shares are admitted for trading on various stock exchanges and can be traded on the secondary market. The price of the shares offered on the secondary market may deviate from the net asset value of the shares. |
| Term: | No fixed term. We are entitled to terminate the management of the Product by giving at least one month notice to investors as published at least on our website. |
| Objective: | <p>The Product's investment objective is to replicate, before fees and expenses, the MVIS® Global Digital Assets Equity Index (the "Index"). In order to seek to achieve its investment objective, the Manufacturer will use a replication strategy by investing directly in the underlying equity securities of the Index being the stocks, American depository receipts (ADRs), and global depository receipts (GDRs). Such equity securities must be issued by companies who generate at least 50% of their revenues/assets from the global digital assets segment, listed or traded on the Markets referred to in Appendix II of the Prospectus. For the avoidance of doubt, where the Index already holds such equity securities, the Index will seek to remove the security when the percentage of revenue generated from the global digital assets segment, drops below 25% of the relevant company's revenues.</p> <p>Where it is not practical or cost efficient for the Product to fully replicate the Index, the Manufacturer may utilise an optimised sampling methodology. Where it is not practical or cost efficient for the Product to fully replicate the Index, the Product will not avail of the increased limits as set out in Regulation 71 of the UCITS Regulations.</p> <p>The Product may invest up to 15% of its Net Asset Value directly in shares issued by companies listed on the Shanghai Stock Exchange or the Shenzhen Stock Exchange. What are the risks and what could I get in return?



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your Product easily or you may have to sell at a price that significantly impacts on how much you get back.

What happens if VanEck Asset Management B.V. is unable to pay out?
