

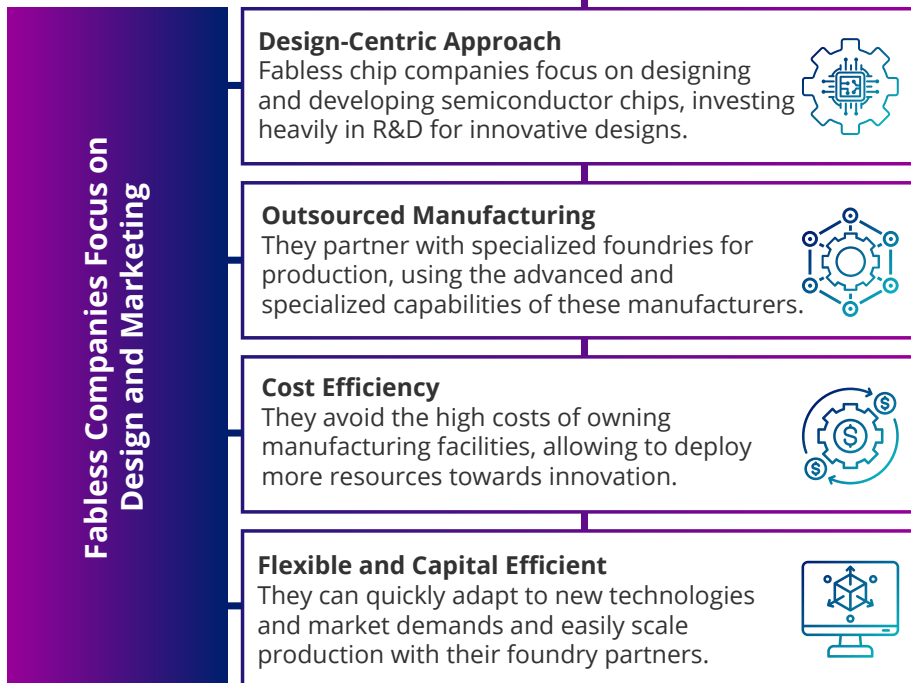
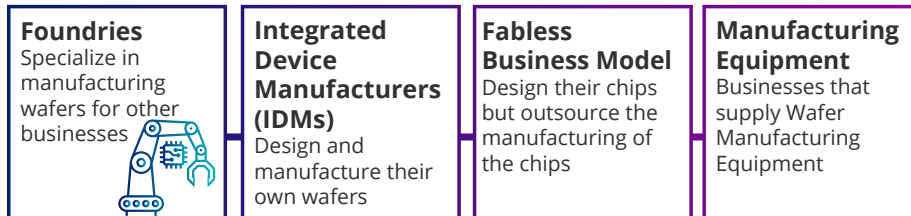

The semiconductor industry is comprised of four main business types. Foundries, Integrated Device Manufacturers (IDMs), Fabless, and Equipment. SMHX focuses its attention on fabless semiconductor companies. These businesses design chips in-house and then outsource the manufacturing of their designs to foundries.

VanEck Fabless Semiconductor ETF (SMHX) seeks to replicate as closely as possible, before fees and expenses, the price and yield performance of the MVIS® US Listed Fabless Semiconductor Index (MVSMHX), which is intended to track the overall performance of companies involved in semiconductor industry and operate as fabless semiconductor companies. Such companies may include small, medium- and large-capitalization companies and foreign companies that are listed on a U.S. exchange. To be initially eligible for the Semiconductor Index, companies must generate at least 50% of their revenues from the semiconductor industry and operate as fabless semiconductor companies. A fabless semiconductor company is engaged in the design and sale of semiconductors and hardware while outsourcing all product manufacturing.
